# 1. Meeting Called to Order

# East Coventry Township

Mr. Woessner noted that the Zoning Officer did not approve the occupancy computations for the proposed elementary school and the school has decided to not appeal such decision.

## Lower Pottsgrove Township

Mr. Troutman noted the Spring Valley development (178 homes) and the Sanatoga Green project. Mr. Troutman also noted that there has been interest shown in the old car dealership property on High Street. The Liberty Thrift is to open in June.

## New Hanover Township

Mr. Zebrowski noted there is nothing new to report for New Hanover Township.

## North Coventry Township

Mr. Marks noted that their Planning Commission cancelled their May meeting and also noted that North Coventry is working on their sign ordinance and basing the proposed ordinance on Montgomery County's ordinances. The Big Woods Festival had a great turnout.

## Pottstown Borough

Mr. Procsal noted the Farmer's Market grand opening on May 26. Mr. Weand noted a final plan for the commercial portion of a project at Industrial and Hanover Streets has been approved. Also noted was that American Keg will be operating at 21 Robinson Street and they are the only manufacturer of beer kegs and they will have 17 employees with plans to add a second shift. Mr. Weand noted lack of funds for the 4<sup>th</sup> of July event and the group discussed cost sharing options.

Mr. Taylor noted there is nothing to report for Upper Pottsgrove Township

## West Pottsgrove Township

Mr. Gentile noted the Fishing Rodeo on May 28 and Community Day on June 11. Also noted was that permission was given to move ahead with the preliminaries for the project at 1097 State Street.
