## 6. Treasurer's Report

Ms. Bice noted that the past loans to the Mini-Grants Account have all been repaid to the Administrative Account but there is an outstanding loan from the Administrative Account to the Circuit Rider Account.

Mr. Kuklinski moved to reimburse the Administrative Account in the full amount that was loaned to the Circuit Rider Account by adding \$119.83 to the annual bill of the six participating communities to make up the \$719.00 shortfall, contingent upon receiving the full requested closeout amount from DCNR for Year 3 of the Circuit Rider program. Mr. Weand seconded the motion. The motion carried unanimously.

Mr. Kuklinski moved to proceed with transferring \$6,531.00 from the Circuit Rider Account to the Administrative Account to partially repay the past loan of \$10,500.00. Mr. Troutman seconded the motion. The motion carried unanimously.

Ms. Bice noted that a separate bank account should be opened for the DCNR grant for the engineering of the Tri-County Trails project for record keeping.

Mr. Kuklinski moved to approve the January Treasurer's Report. Mr. Weand seconded the motion. The motion carried unanimously

Karen Whitaker, Transportation Planner for the DVRPC was present to assist the Committee with Traffic Study Update map assignments. Representatives from the different communities placed notifications on corresponding maps identifying traffic areas of concern. DVRPC representatives will categorize the selections and provide their conclusions at a later date.

Jamie Gwynn, New Hanover Township Manager, requested that DVRPC provide general cost estimates for the targeted traffic area improvements.

There was discussion how PennDot is aware of the need to communicate with local municipalities as projects are planned and the levels of communication are to improve.
