## 7. Presentation: "Community Impacts of Multifamily Development"

Andrew Svekla, AICP, Associate Manager, Smart Growth, DVRPC, provided a presentation on Community Impacts of Multifamily Development.

- Renting is as high was it was in the 60's.
- Impacts and benefits of higher density residential were noted.
- The changing population is driving the demand for new types of homes: older segment is renting
- Key is to provided mixed uses, grow responsibly, and manage growth development while protecting natural resources.

- Higher density is sometimes difficult as it may not be compliant with existing zoning.
- Key measures of potential impact of development, how they are affect economy, transportation and community.
- The key takeaways are household size, focus on school age children and vehicle ownership.

# 9. Development of Regional Impact – Westwood/Maguire – New Hanover Township

The Westwood/Maguire Development proposes 38 twins, 26 village houses, 8' wide bike path along Rhoads Road, internal sidewalk network, and 18 guest parking spaces. Public sewer is accessible from Rhoads Road. Mr. Woessner noted the lack of emergency vehicle access in the cul-de-sac and noted an alternate route should be provided.
