1. Meeting Called to Order

Mr. Soumis called the meeting to order at 7:00 p.m.

2. Roll Call

Mr. Soumis did a roll call and all municipalities were represented except for Pottstown Borough, East Coventry Township, West Pottsgrove Township, New Hanover Township representative Kurt Zebrowski arrived at 7:10 p.m.

3. Pledge of Allegiance

The Pledge of Allegiance was recited.

4. Review of the May Meeting Minutes

Mr. Marks moved to approve the May 26, 2021 meeting minutes as presented. Mr. Hiryak seconded the motion. The motion carried with Mr. Churach abstaining due to his absence at the May 26, 2021 meeting.

5. Treasurer's Report

Mr. Troutman moved to approve the June 2021 Treasurer's Report. Mr. Churach seconded the motion. The motion carried unanimously.

7. Update – Tri-County Passenger Rail Committee

Matthew Edmond, AICP, MCPC Assistance Director of Transportation and Long-Range Planning, provided an update of the Tri-County Passenger Rail Committee. The Tri-County Passenger Rail Committee meets once a month to create a consensus of what to achieve and do fact finding along with communicating with owners of local rail systems Norfolk Southern, Septa, Amtrak, and to try to secure grants to do studies. Meetings to continue into the Fall and projections to be established.

Mr. Soumis inquired about why the rail service stopped in this area and costs and low ridership was noted and the inability to electrify the rails which would have created cost savings. Mr. Marks asked how rail service could affect development and it was noted that DVRPC can look into that.

8. Update – High Street Corridor Study

Ms. Bice noted a virtual meeting for the High Street Corridor Study was held May 27 and there was discussion and feedback on the topic of angular parking, DVRPC noted that angular parking is doing well but not all agree.

9. Municipal Updates

Douglass Township

Mr. Hiryak noted that construction of the new Emergency Services building on New Philadelphia Avenue and Route 73 is projected to be complete by the end of 2021 or early 2022.

East Coventry Township

No one was present.

Lower Pottsgrove Township

Mr. Troutman noted that Spring Valley has not been completed sold yet.

New Hanover Township

Mr. Zebrowski noted there is nothing additional to report for New Hanover Township.

North Coventry Township

Mr. Marks noted there is nothing additional to report for North Coventry Township.

Pottstown Borough

No one was present.

Upper Pottsgrove Township

Mr. Churach noted there is nothing additional to report for Upper Pottsgrove Township.
