- **1. Meeting Called to Order and Pledge of Allegiance:** Mr. Marks called the meeting to order at 7:00 p.m. and the pledge of allegiance was recited.
- **2. Roll Call:** Mr. Marks did a roll call and all municipalities were represented, except for West Pottsgrove.

3. Review of the August 2023 Meeting Minutes

Mr. Procsal moved to approve the August 23, 2023 meeting minutes as presented. Mr. Troutman seconded the motion. The motion carried with unanimously.

4. Treasurer's Reports

Mr. Troutman moved to approve the September 2023 Treasurer's Report. Mr. Waldt seconded the motion. The motion carried unanimously.

5. Public Comment

Mike Hayes of Montgomery County was present and asked the group if they would be interested in looking at the Regional Comprehensive Plan as it was last revised in 2015 and asked the group how the region is trying to meet affordable housing needs. Mr. Marks suggested Mr. Hayes contact Ms. Bice for the requested information.

6. Review: 2024-2026 Planning Assistance Contract Renewal

Mr. Troutman moved to approve the 2024-2026 Planning Assistance Contract Renewal. Mr. Procsal seconded the motion. The motion carried unanimously.

7. Review: Draft 2024 Budget & Invoice Amount

Mr. Waldt moved to approve the 2024 Budget and Municipalities' Invoice Amount as presented. Mr. Tietjen seconded the motion. The motion carried unanimously.

- **8.** Ordinance Review: Douglass Township Active Adult Overlay Zoning Text Amendment Mr. Tietjen moved that the Douglass Township Active Adult Overlay Zoning Text Amendment is generally consistent with the Regional Comprehensive Plan. Mr. Troutman seconded the motion. The motion carried unanimously.
- 9. Ordinance Review: Douglass Township Active Adult Overlay Zoning Map Amendment Mr. Troutman moved that the Douglass Township Active Adult Overlay Zoning Map Amendment is generally consistent with the Regional Comprehensive Plan. Mr. Procsal seconded the motion. The motion carried unanimously. Noted were concerns regarding traffic.
- **10. Development of Regional Impact: Village at Fricks Lock East Coventry Township**Village at Fricks Lock East Coventry Township proposed subdivision and land development of 155 single-family detached residential units near the intersection of Fricks Lock Road and Schuylkill Road (S.R. 724) including the realignment of Fricks Lock Road and a total of 58.7 acres of open space. Noted were parking and traffic circulation concerns. Mr. Soumis asked if EDU's needed are consistent with the North Coventry agreement and Mr. Tietjen noted that is being discussed.

11. DVRPC 2025 Work Program Project

The suggested project for the DVRPC FY 2025 Work Program is to do a study related to the Schuylkill River Passenger Rail Authority (SRPRA)

Mr. Marks felt that the SRPRA study is a bit premature and noted concerns of doing a study that will not come to fruition. Mr. Soumis noted there are numerous other road projects in the region that may be better served. The motion did not pass. The matter to be discussed further at a later date
