1. Meeting Called to Order: Mr. Marks called the meeting to order at 7:03 p.m.

- 2. Pledge of Allegiance: Mr. Marks led the reciting of the Pledge of Allegiance.
- **3. Roll Call:** Mr. Marks did a roll call and all municipalities were represented except for New Hanover Township.

4. Review of the June 2024 Meeting Minutes

Mr. Weand moved to approve the June 26, 2024 meeting minutes as amended. Mr. Shawell seconded the motion. The motion carried unanimously. Amendment being add Wayne Weaver representing Upper Pottsgrove to the attendees.

5. Treasurer's Reports

Mr. Procsal moved to approve the July, August and September 2024 Treasurer's Reports. Mr. Weand seconded the motion. The motion carried unanimously.

6. Public Comment

Mike Hayes noted the Montco Project and the Comprehensive Plan updates stating that there is need for more housing and municipalities need to be more ambitious with fair share housing as there is a dire need for affordable housing.

7. Comprehensive Plan Review Items:

a. Draft Parks & Open Space Chapter & Discussion

Tricia McCloskey, AICP, PARRC, Regional Recreation Planner

Mr. Hartman noted that Montgomery County usually uses \$1.5-2M annually for county acquisitions and grants. Montgomery County has an open space fund of \$3.5M annually. Monies for which could be used to fill the Schuylkill River Trail gap to have the trail go directly from Philadelphia to Berks County. There is over \$40M in Federal funding the Schuylkill River Trail.

Mr. Stauffer noted that the Chester County has grant monies for land preservation also noting that 31% of County land area is being preserved. The County has a 35-year commitment for land preservation. The County is looking to make additional trail connections and is looking to municipalities, residents, and business to do that with funding assistance through the County Program.

Ms. McCloskey noted that there is \$6.9M in grants that are funding local recreation projects.

- Pickleball/tennis courts (Douglass Township)
- Riverside Park, kayak launch (North Coventry Township)
- Boat launch, connect the Heyser Tract to Towpath Park (East Coventry Township)
- Development of Chestnut Park and South Street Park (Pottstown Borough)

Updates to be implemented into the Parks & Open Space Chapter per comments received.

b. Community Survey Status & Outreach

Ms. Bice provide an update of the Community Survey. Ms. Bice noted that 607 responses have been received a survey end date will be set to September 30.

Mr. Duncan noted that a walking path along with a pickleball court is planned. A 17-lot proposed subdivision along Moyer Road has been submitted, the project borders another proposed community behind Twin Ponds Golf Course.

East Coventry Township

Mr. Tietjen noted there is nothing additional to report for East Coventry Township.

Lower Pottsgrove Township

Mr. Troutman noted the Wawa and Royal Farms are under construction.

New Hanover Township

There are no representatives present for New Hanover Township.

North Coventry Township

Mr. Marks noted that North Coventry Township is close to obtaining 55 acres of conservation easements. Starbucks has opened at Suburbia Shopping Center.

Pottstown Borough
